CSW Now Accepting Applications for Awards in Feminist Scholarship, Advocacy and Teaching

The Association for Education in Journalism and Mass Communication Commission on the Status of Women is seeking applications for its annual awards.

Mary Gardner Award for Graduate Student Research

Graduate students who conduct research on women in journalism and mass communication are invited to apply for the Mary Gardner Award. This award is designed to fund research that has the potential to make an excellent contribution to

the scholarship on women and journalism and mass communication. The award honors Mary Gardner, who was a professor at Michigan State University and the first woman elected president of AEJMC. Applicants send a three-to-five page description of the project and its potential contribution and a brief one-page description of the applicant's qualifications for undertaking the project. A three-person panel judges the applications. \$250 awarded to the winner.



Mary Ann Yodelis Smith Award for Feminist Scholarship

Applications are invited for the Mary Ann Yodelis Smith (MAYS) Award which funds feminist scholarship that has the potential to make significant contributions to the literature of gender and media. First presented in Mary Ann Yodelis Smith 1995, it honors Mary Ann

Yodelis Smith, a past presi-

dent of AEJMC and long-time advocate for women in the academy. Applicants send a five-to-seven page description of the project and its potential contribution to the scholarship on gender and the media and a brief one-page description of the applicant's qualifications for undertaking the project. A three-person panel, including a past recipient of the award, judges applications. \$500 awarded to the winner.

Donna Allen Award for Feminist Advocacy

The Donna Allen Award recognizes feminist advocacy by a woman or group. This award honors Donna Allen, founder of the Women's Institute for Freedom of the Press in Washington, D.C. Submissions, four-to-six pages, should describe the nominee and demonstrate how the nominee's feminist

media activism promotes the rights and freedoms of women and minorities across the world. Nominees need not be AEJMC members. A three-person panel judges the nominations. \$100 awarded to the winner.

Outstanding Woman in Journalism and Mass Communication Education Award

This award honors a woman who has represented women well through excellence and high standards in the education of journalism and mass communication. Nomination letters, three-to-five pages, must detail that individual's contributions to journalism and mass communication education. A three-person panel judges the applications. \$100 awarded to the winner.

Deadline for all awards is MAY 1, 2010.


Winners will be announced at the 2010 AEJMC annual convention in Denver, during the AEJMC business meeting (Friday evening; location to be announced).



CSW Member Update: Neilsen Speaks at Human Rights Conference

Carolyn Nielsen, Western Washington University, served as a speaker at the 12th annual Martin Luther King, Jr. Human Rights Conference in Bellingham, Wash. on Jan. 16. Her presentation, "Fear Factor: Media Effects and Public Opinion," was part of the conference themed, "Books not Bars: Education, the Media and America's Prison System."

In addition to discussing media effects, Nielsen talked about her 1995 coverage of the conviction of Thaddeus "T.J." Jimenez, who was arrested on suspicion of murder at age 13 and tried as an adult in Cook County Superior Court. Nielsen's article for Northwestern University's graduate school magazine raised questions about the judicial process in Jimenez's case. With the help of the Northwestern University School of Law's Center on Wrongful Convictions, Jimenez was exonerated in May 2009 after being incarcerated for nearly 16 years for a murder he did not commit. Jimenez is the youngest person ever to be exonerated.

Former CSW Officers Reflect on the Commission's 20th Anniversary

n 2010, the Commission on the Status of Women (CSW) celebrates its 20th anniversary as an AEJMC commission (and its 37th since being founded as an AEJ committee). At the annual conference in Denver, Friday, Aug. 6 will be "Status of Women Day." The day-long celebration will feature a mentoring and networking luncheon as well as a panel entitled "Our Voice, Our History: 20 years and Counting."

As we approach the AEJMC annual conference, former officers were asked to reflect on the commission's history and milestones.

Environment of empowerment - Former officers recalled CSW serving as a support system and resource for feminist scholars. Officers remembered, in particular, how the commission helped women through difficult tenure and discrimination cases. One former officer shared, "Those sessions sustained our sanity and empowered us to continue."

A place for new scholars – The Commission on the Status of Women has enabled graduate students and new feminist scholars to debut their research. Former officer Carolyn Byerly shared, "When I think of CSW, I remember my graduate school years. I was asked to speak on a panel sponsored by CSW about a topic I no longer remember. Just the invitation made me feel that I mattered and might have a place in the academic world..."

Funding CSW – Research by CSW members has funded awards and scholarships to support feminist communication scholars. Former officer Pam Creedon shared how the authors with chapters in the first and second editions of Women in Mass Communication: Challenging Gender Values (Sage 1988,1996) donated all royalties from the book to the ACEJMC Commission on the Status of Women. The total donation over the years helped to fund one or more of the Commission's annual awards.

Documenting CSW history - Former CSW Chair Von Whitmore produced a collection of podcast interviews with former CSW leaders Ramona Rush, Carol Oukrop and Judy VanSlyke Turk. They can be accessed through the Commis-

Working for women's equity – Former officers shared how the commission has fought for women's equity and continues to provided a place for feminist scholars to collaborate, network and promote excellent scholarship.

The mentoring activities are envisioned to be more structured. Mentoring would have the goal of matching up senior colleagues with junior colleagues for a specified period of time to accomplish one or more things associated with career building. We three have drafted a skeleton plan for such a mentoring program and are in the process of collecting feedback from both junior and senior colleagues and graduate students at our respective campuses.

CSW members will have an opportunity to react to a proposal in Denver, during the networking luncheon.It's anticipated that it will take 1 to 2 years to establish the mentoring program and get it running on some kind of a trial basis.
