# International Communication Division Meeting Agenda Montreal, Canada, August 7, 2014 8:30 p.m. – 10.00 p.m.

### 1. CALL TO ORDER

- 1.1. Out going Division Head, Celeste Gonzalez de Bustamante calls meeting to order.
- 1.2. Gonzalez de Bustamante introduces division leadership who worked with her the past year.
- 1.3. Gonzalez de Bustamante begins with the call to order

#### 2. ATTENDANCE

- 2.1. Based on the information from the attendance sheet passed around during the meeting, 36 members are present at the meeting.
- 2.2 The meeting approved the minutes of the previous meeting following corrections regarding names and some specific points recorded in the minutes. These have to do with point 4.3.4 related to the next WJEC event whose date is yet to be set.

#### 3. NEW AND CURRENT BUSINESS

- 3.1 Report on conference activities from out-going head; ICD has 270 paid members, 16 more than the last year. Seventy reviewers contributed to the blind peer review process. ICD organized one pre-conference session, six –refereed research sessions, two invited teaching session, two invited PF&R sessions.
- 3.2 The outgoing head said ICD underwent through an evaluation and the feedback received was very positive. The assessment identified the positives and also some weaknesses of the organization. The report of this evaluation will soon be online. One of the issues raised during the evaluation was that ICD is one of the largest divisions and there is need to recruit new reviewers.
- 3.3 The outgoing head reported the success of a coffee chat with Catherine Cano, Executive Director of News Programs for Radio-Canada. Twenty-five people attended the session. More similar events will be organized in future conferences and the focus would be on making the venue less formal to encourage interaction.
- 3.4 In the domain of information sharing, the outgoing head reported that Twitter and Facebook accounts were created, in addition to a listserv and a website

- 3.5 She also mentioned that ICD has established a fundraising committee and suggested that actual members could continue. In addition to that, she invited interested members to join the committee.
- 3.6 Five past presidents were acknowledged for the services rendered to the ICD. These were: 1. Celeste Gonzalez de Bustamante 2. Heloiza Herscovitz, 3. Manual Chavez, 4. Margaretha Geertsema-Sligh, and 5. Amy Schmitzitz Weiss.

### 4.3. RESEARCH

- 4.3.1 Kalyango thanks Zeny Sarabia-Panol, the outgoing editor of International Communication Research Journal and provides a brief overview of the journal's origin. Zeny reports that the journal's acceptance rate has come down to 12% and she will work with Kalyango on the December issue.
- 4.3.2 Kalyango says that to get a professional publisher for the journal, the journal needs to have three issues; it currently has two issues per year. He says that he will do that by bringing out special issues but his immediate focus is to index the journal and he has already been exploring ways to do it through EBSCO host. He presents more ideas based on suggestions from members to increase the visibility of the journal.

4.3.3 Kalyango reports that Stevenson paper competition received 83 faculty submissions out of which two were removed for noncompliance to the rules. Thirty-nine papers were accepted and 42 were rejected. Acceptance rate was 48%. For the Markham student paper competition, 34 submissions were received, one submission was rejected for providing identifying information in the manuscript, and 13 papers were accepted. Acceptance rate was 39%. Overall, the acceptance rate was 46%. 52 papers were accepted and 62 were rejected. Qualtrics, email contact, and word of mouth were used to recruit reviewers. Seventy one reviewers participated in the review process and each reviewer had around 5 papers to review.
