AEJMC charges all divisions and interest groups to attend to three important foci when planning the annual convention—Research, Teaching, and Professional Freedom & Responsibility (PF&R).

For Research, MC&S will provide about 40 slots via two research panels, one high-density research panel, one scholar-to-scholar panel, and at least

one poster session. Moreover, MC&S will collaborate on six themed panels with eight other divisions/interest groups.

For Teaching, MC&S will host one pre-conference panel, "Teaching the introductory mass communication course: Tips and tactics," and two other teaching-themed panels later in the convention week.

For Professional Freedom & Responsibility, MC&S will facilitate exploration of these key issues during one Mini-Plenary session, "Issues and agendas of campaign 2008," and three themed panels during the convention.

Many thanks to everyone who submitted panel proposals back in the fall. I could not have put together such high-quality programming without your support. Stay tuned for program details in our next newsletter as we countdown to Boston!

Submit 2009 Convention Papers by April 1

Papers on a wide variety of topics and methods are welcome for submission to the Mass Communication & Society Division for the 2009 AEJMC national convention in Boston. Faculty and students who have papers fitting the broad field of mass communication and society should strongly consider submitting to the popular division.

At least one author of any accepted paper must be available to present the paper at the Boston convention.

Mass Communication & Society offers separate financial prizes to the top papers from students and faculty. All papers are judged together as general papers, but top papers for each competition are recognized separately. Papers submitted for the special-call panel may also be considered for presentation at other MC&S research-paper sessions. To qualify as a student paper, all authors on the paper must be students. In addition, AEJMC waives one convention registration for each of the four top student papers.

Be sure to visit the AEJMC uniform convention call web page at http://www.aejmc.org/_09call.php for steps on submitting your paper to the 2009 competition.

Author anonymity is critical to the fairness of the judging of entries. Authors submitting a paper should remember to remove all identifying information from their papers. Any paper submitted with identifying information visible in the document will be disqualified. For details on how to submit a "clean" paper, visit

the AEJMC web page at http://www.aejmc.org/_events/convention/papercall/cleanpaper.php. Your identifying information will be captured in AEJMC's online database when you submit your entry.

MC&S is open to a wide variety of recognized research methods and citation styles. The division restricts papers to 30 double-spaced pages, including all text and supporting material. Papers should be submitted exclusively to MC&S. Papers are ineligible if they have been previously presented or published, are being considered for publication, or have been submitted to another AEJMC division.

Authors may submit no more than two papers to the MC&S competition. If a submitter's name appears on more than two papers, including as co-author, only the first two submitted will be reviewed.

Once again, submissions to the MC&S competition must be submitted to the AEJMC convention web site at www. aejmc.org/09convention. The deadline for submissions is 11:59 p.m. Central Daylight Time on April 1, 2009. Papers may be submitted in Word, WordPerfect or PDF formats, although Word and PDF are preferred. Be sure to also include an abstract of up to 75 words. Papers that are printed out will not be accepted, nor will any papers submitted electronically to the research co-chairs.

Call for Judges

The need for judges in MC&S's refereed paper competition continues to grow with the popularity of the division. You should receive your review assignments by mid-April and have until early May to complete reviews.

Special Calls for MC&S Research in 2009

During the 2009 AEJMC Convention, the division is holding a special call for research related to "Media and Social Change," along with the annual student Moeller paper competition.

The special research call examines the relationship between media and social systems, especially as those relationships facilitate or hinder social change. Those papers that focus on sociological movements are especially encouraged. Examples of potential topics include protest coverage, technology and change, and advocacy, but other topics will also be considered.

In addition, cash awards will be given for the top faculty and student papers submitted to MC&S. Members voted to raise the top awards to \$250 for the top faculty paper award in 2009. The division waives one convention registration

for each of four student winners. Papers submitted in the student contest must contain all student authors

Papers submitted for the special call will also be considered in the open paper competition, but winners will be recognized separately in a dedicated research panel.

Students who submit a paper written for a class during the previous year are eligible for the Mass Communication & Society Moeller paper competition. As part of the submission process, the faculty member who taught the class must send a letter or e-mail verifying that the paper was completed for a class. The letter should be sent to Michael McCluskey at mccluskey.14@osu.edu and must include the faculty member's affiliation.

The 2008 winners of the Moeller Award were Pamela Brubaker, Michael Horning, and Christopher Toula, of Penn State University.

Submit Your Scholarship to MC&S

The continued growth and popularity of Mass Communication & Society makes the division a great place to get exposure in mass communication research, so my cochair and I urge you to think of MC&S as a location for your scholarship in 2009.

For the past few years, MC&S has had highest number of submissions of all AE-JMC divisions. In 2008, we received 150 submissions, and we accepted 74 of those for roughly a 50 percent acceptance rate.

All papers, including those authored by graduate students and those submitted for special calls, are put through a blind peerreview process. Only faculty—not graduate students—can serve as reviewers, and each paper generally receives three to five reviews.

Our goal is to not only showcase and reward the highest quality research at the convention, but also to provide meaningful and thoughtful feedback to scholars as they develop their research.

Arguably, MC&S is the AEJMC division with the broadest focus, which means we receive paper submissions with a wide array of interests and specialties. Thus, it is

incumbent upon the research chairs to find ways to showcase quality research in varying venues. We attempt this by using the scholar-to-scholar (S2S) and poster sessions.

Often, we receive excellent papers that don't quite fit into a specific research panel, so we'll place that one in a poster session. Other times, a paper submission has a specific visual presentation that we think would play well on a poster.

Since all papers are peer-reviewed through the same process, those accepted into poster sessions are considered as high quality as those selected for research panel presentations. No one should be slighted by being assigned to a poster session, as that research is just as strong-if not strongerthan papers assigned to a research panel.

The other benefit to submitting to MC&S is that we've got some great awards, which are outlined in other articles in this newsletter. There's Always Something New with Your Division Journal

We have been striving for a turnaround time of fewer than 90 days, and 75 percent of our authors receive decisions in under three months' time. That should be especially good news for professors seeking tenure and promotion. Expect the fastest turnaround time to publication for manuscripts on the symposium topic (see below).

Documentary Symposium Deadline Extended

Mass Communication and Society received about half as many submissions for this year's symposium, which is scheduled to be released at the end of 2009. The symposium, which is being guest edited by Mathew C. Nisbet and Patricia Aufderheide from American University, will feature manuscripts on the role of the documentary in society. The deadline to submit papers to this special symposium was January 12. However, Nisbet and Aufderheide will still accept additional manuscripts for a short time. Manuscripts should follow the standard submission procedures outlined in the journal's inside back cover. Authors should also specify in their submission letter that they want their submission to be considered for the documentary symposium. Two candidates applied for the journal's open book review editor position. We are proud to announce Dr. John Pollock has been selected to serve in this role. Pollock is a Professor in the Communication Studies Department at the College of New Jersey. He received his B.A. from Swarthmore (political science), M.(I)P.A. from the Maxwell School at Syracuse (international public administration) and Ph.D. from Stanford (political science). Dr. Pollock has authored *The Politics of Crisis Reporting: Learning to be a Foreign Correspondent* (Praeger) and coauthored two other books.

In his new role as book review editor of *Mass Communication and Society*, Pollock will be responsible for choosing titles and inviting 1,000- to 1,200-word reviews. Journal Article Earns Press

In late October our journal received notable press coverage from multiple newspapers for an article published in volume 11, issue 4. The article, Celebrity Endorsements and their Potential to Motivate Young Voters, was authored by Erica Austin, Bruce Pinkleton, Rebecca Van de Vord and Evan Epstein from Washington State University. Reports on this manuscript were featured in the States News Service News Wire, Associated Press State and Local Wire, *Toronto Star, Calgary Herald* in Alberta, Canada, and the *Philadelphia Daily News*. The authors were also interviewed on Northwest Public Radio, on afternoon drive radio programs in Seattle and California. We are proud that the research published in our journal is gaining recognition both nationally and internationally.

Call for 2009 MC&S Research Award Proposals

The Mass Communication & Society Division will provide a grant of up to \$5,000 to encourage high-quality research on media and society. The funds may be awarded to a single project or to two smaller projects. The funded research must be submitted to *Mass Communication and Society* for review within two years of the award. Deadline for proposals is May 1, 2009.

ELIGIBILITY: Any MC&S member who is currently teaching, researching or studying mass communication full time is eligible. Members of the division executive committee or the selection committee are ineligible.

Any topic and methodology that advances mass communication research, especially at the societal or macrosocial level, is eligible for the award. Proposals must emphasize the interaction with society and also fit with the division's mission.

PROPOSAL: The proposal should total no more than five pages, single spaced. It should include the following sections: An overview of the study, stressing the importance of the topic and the fit with the division's mission. This section should include research questions and hypotheses, if applicable; A brief literature review citing the most relevant articles and describing where the project fits with past research; Proposed methods, with as much detail as possible; A

proposed timeline from inception of the project to *Mass Communication* and Society submission. Note: The project must be completed within two years (and the selection committee encourages a faster timeline, if possible).

Submissions should also include a current curriculum vita and a detailed project budget.

SUBMISSIONS: Submissions should be sent electronically to Jennifer Henderson, division head, at jhender4@ trinity.edu. Attach all required materials in either Word (with .doc extension), Excel or pdf files. Hard copies will not be accepted.

In 1998, the Mass Communication and Society Division introduced its first batch of "Promising Professors" to the rest of the academic community. Every year since—including this summer in Chicago—the division has honored its best and brightest teachers, and the idea that was begun 10 years ago to recognize excellence in pedagogy continues to grow in popularity and stature.

Past winners continue to flourish in their current academic positions, and they certainly acknowledge the role that the Promising Professors competition played in helping them secure jobs and advance in their careers. In fact, the most recent recipient of our Distinguished Educator Award–Pat Curtin, University of Oregon–actually was among the earliest Promising Professors winners 10 years ago.

Not only has the competition enjoyed an increase interest and prominence over the years, but the MC&S Division is the only division of AEJMC that offers such a prestigious award for teaching. The competition is open annually to: new instructors and faculty with no more than five years of full-time teaching experience, and graduate students who have primary teaching responsibilities for at least one class.

Promising Professors Competition & Workshop

The AEJMC Mass Communication & Society Division and Graduate Education Interest Group will honor our best and brightest teachers during the Promising Professors Workshop Panel at the national convention in Boston.

ELIGIBILITY: Faculty who have taught no more than five years full-time and graduate students who have primary responsibility for teaching at least one course are eligible. All entrants must be members of the Mass Communication and Society Division. If you're not a division member, contact AEJMC at www. aejmc.org to join.

AWARDS: Winners will be selected through a judging process and will receive cash awards.

WORKSHOP: There is no better way to kick off a new school year than by thinking about teaching and learning in new ways. Winners will be required to attend the Promising Professors Workshop Panel and Breakfast at the AEJMC national convention, where they will share insight on best practices for teaching.

DISTINGUISHED EDUCATOR AWARD:

Nominations also are being accepted for the Distinguished Educator Award, which is given annually to a MC&S member whose personal teaching excel-

lence and influence on pedagogy in the field is profound. If you know a faculty member who has served as a mentor and role model for your teaching, please consider nominating her/him for this prestigious award.
