### From the Division Head

Dear Colleagues and Friends,

Greetings from Tucson, Arizona, just an hour's drive north of the Mexico-U.S. border.

As we move into the second half of the academic year, the International Communication Division has launched a number of new initiatives to expand our global reach, and we have built on important projects from recent years. We also have made some changes in response to the excellent comments that we received from the last survey of the membership. Thank you all for your support and interest.

In this newsletter, you will find that the ICD Executive Board has expanded. In an effort to build collaborations around the world and to learn from our neighbors, we have grown the number of seats to include research liaison posts for Asia, Europe, Latin America and the Caribbean, the Middle East and North Africa, Sub-Saharan Africa, and Oceania. We are discussing the possibility of adding teaching liaison work for this outreach to professional and academic colleagues in other (see Page 27)



### From the Vice-Head

Our programming for AEJMC 2016 is almost complete and the International Communication Division is sponsoring four preconference sessions and six conference panels in addition to the refereed paper research sessions.

For the pre-conference scheduled on Wednesday, August 3, 2016, ICD will begin with a Professional Freedom and Responsibility (PF&R) session titled: "The Shrinking Public Sphere": Growing Restrictions on Press Freedom in South and South East Asia. In this panel, presentations will focus on how freedom of expression—both online and offline—is being impacted in the region including in nations that lay claim to democratic status. Drawing on empirical research in countries ranging from Bangladesh, Pakistan, India and Nepal to Burma

and Thailand, the panelists will explore the complex and varied constraints operating against freedom of the press as well as the manner in which journalists seek to negotiate these constraints. Among some of the issues that panelists will explore are the legal restrictions imposed on the news media in Thailand, the impact of growing political ownership and economic consolidation in India and Pakistan, challenges faced by journalists from the government in Burma and attacks on bloggers and citizen journalists by Islamic groups in Bangladesh. All the panelists have worked and conducted communication research in Asia. The session is from 1 to 1:50 pm.

The PF & R session will be followed by a research session: "Risk and Crisis in Journalism and Communication: Research Applications," where presenters will provide a comprehensive overview of recent research advances internationally and with focus on several world regions. Through a workshop/roundtable approach participants will address the following questions: How does crisis communication deepen understanding about the realities of other countries and communities? What are the on-the-ground concerns for professionals and professors who research risk and crisis? Are there tenets proposed by crisis communication to be useful in international comparative research? Panelists have extensive academic research experience on international crisis communication in different fields and world areas. The session is from 2 to 2:50 pm.

The research session will be followed by a teaching session: "Innovating Public Diplomacy in the Digital Age: An international multimedia collaborative storytelling experiment, connecting global cities." The panelists will present the comparative results of an on-going international multimedia collaborative storytelling experiment, designed as a platform for innovating public diplomacy in the digital age. It connects young leading student communicators in five cities, on four continents. The connected teams of professors and students see themselves as voluntary citizen diplomats voicing and sharing their stories and providing diverse contexts for different aspects of their cities' lives and challenges. This international city-diplomacy multiplatform storytelling experiment program has the (see Page 29)

### **ICD Teaching Contest**

To promote teaching excellence and recognize innovative and effective approaches to teaching international communication, ICD invites you to submit class-tested activities (these can be larger or smaller projects, assignments, games and/or simulations, service learning projects, or assessment techniques) that address one or more specific

learning objective(s) in the context of teaching international/global communication/global journalism studies.

Thematic areas could include but are not limited to:

- · Global news engagement
- Global communication research methods
- De-westernizing journalism studies
- International reporting
- Comparative communication or journalism studies research
- Teaching digital security to student reporters

Each contest entry may be between 500 to 1,000 words in length, and must include the following sections:

- 1. Title
- 2. Abstract (100-150 words) with key highlights of the teaching activity.
- 3. A description and explanation of the activity, including a discussion of the learning objective(s).
- 4. Rationale.
- 5. Learning outcomes. When discussing learning outcomes, you may illustrate your points with samples of students' work, pictures capturing different elements of the learning process, feedback by students and/or partnering organizations (if there are any), or any other relevant supporting materials.

Winners of the ICD Teaching Contest (1st and 2nd place) will be recognized at the ICD Business Meeting during the 99th AEJMC Convention in Minneapolis, Minnesota, August 4-7, 2016. Winners will receive certificates and the following prizes:

1st place - \$150 Amazon gift-card to purchase instructional/academic materials, and \$100 in cash/check, sponsored by the *International Communication Research Journal* and the Ohio University Institute for International Journalism. (see Page 6)

#### **ELIGIBILITY**

The ICD teaching contest is open to full-time faculty, adjunct professors, and graduate student instructors who have taught at least one course in the field of international/global communication. The contest is open both to ICD members and non-members.

Current ICD board officers are not eligible to participate in the contest.

#### **EVALUATION CRITERIA AND SUBMISSION PROCESS**

Submissions will undergo a double-blind peer-review process, and will be evaluated according to the following criteria:

- Innovation. To what extent does this teaching activity/project expand the boundaries of existing teaching practices in international/global communication?
- Connection with the learning objective(s). How strong and clear is the relationship between various elements of the activity/project and the learning objective(s)?
- Impact. How well do the learning outcomes correspond to the learning objectives, and how clearly this link is explained and supported in the contest entry?

All proposals must be submitted electronically to ICD Teaching Standards Chair, Anna Popkova, at anna.popkova@wmich.edu by 11:59 p.m. EST on April 15, 2016. All submissions will be subject to a double-blind peer review, so please ensure that your submission is stripped of all identifying information, including in file properties. Decisions will be made by June 1, 2016.

### From the Social Media Coordinator/Chair

Facebook and Twitter are the platforms we selected to communicate with you. Here are some highlights of our social media presence since the Business Meeting in San Francisco in August 2015:

- Facebook is our main social media platform. We went from 320 likes in Aug.4, 2015, to 424 likes on Jan.7, 2016 (a 33 percent increase).
- On Facebook, our "fans" (or people who like our page) are 45 percent female and 53 percent male. But gentlemen, don't sing victory yet. You are more in number of fans, but women interact more with our posts. In terms of people reached, 59 percent are women, and 40

percent are men.

- Our fans are located mainly in the United States (187 people), but we also have a good number of fans who interact with us from countries such as India (36 people), Brazil (24), Mozambique (17), and Egypt (12).
- Fewer fans (between six and 10 people) are located in countries such as Turkey, Canada, Colombia, Ghana, Spain, South Africa, Bangladesh, Nigeria, and Mexico. We have five people or fewer from another 31 nations.
- Our most popular post in the last five months reached 237 different people. Our average is around 70 people reached every time we post.
- On Twitter, we have 72 followers.

### **EWHA-KACA Research Award**



Ewha Womans University, Division of Communication and Media (EWHA) and The Korean American Communication Association (KACA) jointly award outstanding research proposals focusing on Korea-related communication and/or media studies. A total of \$4,000 will be awarded to the winning recipient(s). Ideally, one or two faculty-led projects will be competitively selected to receive \$4,000 (\$2,000 for each of two projects). The half of the award will be distributed at the beginning of the award cycle (August 2016) and the remaining half will be distributed at the completion of the study within two years (August 2018). The research findings should be presented at one of the KACA research sessions at NCA, ICA, or AEJMC 2017-2018.

#### **DETAILS AND HOW TO APPLY**

#### SUBMISSION DEADLINE

All material must be submitted electronically to the Award Committee Chair, Dr. Joonghwa Lee (joonghwa.lee@und.edu), by April 5, 2016 at 11:59pm EST.

#### **RESEARCH TOPIC**

Any topic that advances Korea-related communication and/or media research is eligible for the award. Proposals must emphasize contributions to relevant research streams and the Korean society in general. All methods, whether qualitative or quantitative, are welcomed.

#### **PROPOSAL**

The proposal should be submitted in a word document with the .doc extension, 12 points, Times New Roman, double-spaced with page numbers, 1-inch margin on each side. Otherwise, the proposal will be disqualified. Hard copies will not be accepted. The proposal should be no more than five pages excluding references, timeline, and other additional materials. It should include the following sections:

- . I) An overview of the study, stressing the importance of the topic and the fit with Korea related communication and/or media research.
- . 2) A brief literature review citing the most relevant articles and describing where the project fits with past research; This section should include the research questions and/or hypotheses, if applicable.
  - 3) Proposed methods, with as much detail as possible; (see Page 10)

4) A proposed timeline from inception of the project to presentation at one of the KACA

research sessions at NCA, ICA, or AEJMC (2017-2018). Note: The project must be completed within two years from the date of the business meeting in which the first half of the award is granted.

#### **ADDITIONAL MATERIALS**

Include a current curriculum vita for PI and Co-PIs and a detailed project budget, targeting either \$2,000 or \$4,000, showing how the research funds would be used. For the most part, indirect costs, personal memberships, and subscriptions to software or journals will not be funded, unless justified by the researcher(s). If matching funds are promised by another source, please include a letter (or e- mail) of support from the department chair or other administrators responsible for those funds.

#### **ELIGIBILITY**

Any full-time faculty member who is currently teaching, researching or studying communication or media in North America, Korea, or elsewhere is eligible to apply. To be considered for the award, the PI should be a KACA member as of April 5, 2016. Members of the KACA Executive Committee (2015–2017) are not eligible to apply.

#### ADDITIONAL INFORMATION

Half of the awarded funds will be distributed at the start of the project, and the other half will be awarded when the project is completed and presented at one of the KACA research sessions at NCA, ICA, or AEJMC within the two-year deadline. Recipient(s) are required to submit an annual short progress report. Those who do not complete the project in two years from the date of award become ineligible for the additional funding. Proposals will be blindly reviewed by the selected reviewers, KACA Award Committee, and KACA Executive Committee. The committees reserve the right not to present the award.

#### **Accolades & Activities**

Anne Cooper Chen, professor emerita at Ohio University and former ICD head, is serving as a reader for the Chautauqua Prize. The award, which can be given to any fiction or nonfiction book published in the previous year, would be a good venue for division members' books published in 2016. Even making the short list is a high honor.

**Kevin Grieves,** our membership chair, is scheduled to present the keynote address at the inaugural Transnational Journalism History Conference. The conference, sponsored by Augusta University and Dublin City University, will be held March 4-5 at Augusta University in Augusta, Georgia. Participants from across the U.S. and from Ireland and the United Kingdom will present research at the conference.

This past fall, Kevin started a new position as associate professor in the Department of Communication Studies at Whitworth University in Spokane, Washington.

The board of the Czechoslovak Studies Association voted to honor **Owen V. Johnson**, associate professor (emeritus) of Indiana University with the Stanley B. Winters award for his distinguished contributions to Czechoslovak studies. This award is given periodically to recognize CSA members for their work for the CSA and the field as a whole. The CSA board unanimously agreed that he should receive this award for his longstanding work on behalf of the CSA and his achievements in furthering the field of Czech and Slovak studies in the United States.


#### **Accolades & Activities**

Ammina Kothari, vice-head of ICD and an assistant professor in the School of Communication at the Rochester Institute of Technology, was named one of our four AEJMC Emerging Scholars for 2016-17. Her proposal, "UK Media Coverage of the Syrian Humanitarian Crisis," was selected for funding from among 41 proposals received for the 2016-17 program. Winning proposals were selected based on: (1) innovative approach and importance of the topic to the discipline; (2) quality of the background research and methodology proposed; (3) feasibility of completing the project with the time available; and (4) proposed budget and use of funds.

Diana I. Rios of the Department of Communication and El Instituto at the University of Connecticut is half-way through her second year as president of the university's American Association of University Professors. At UConn she re-ignited Committee W, ("W" for women) of the AAUP chapter, in order to examine gender pay equity. Rios has also begun a three-year term on the governing council of the National AAUP.

Papers that merely examine communication phenomena outside of the United States do not necessarily fit in this division. Any theoretical and methodological approaches appropriate to communication research are welcome. Papers are submitted either to the Robert L. Stevenson open paper competition (faculty and student-faculty) or the James W. Markham student competition (strictly student-authored papers).

All submissions must be uploaded through the AEJMC conference website. Be sure to note whether you are submitting to the Stevenson open paper competition or the Markham student paper competition. Authors will be notified about acceptance in early May. Please note ICD's specific instructions below.

**Guidelines:** Papers should be submitted in Word or PDF format. Do not include any identifying information about the authors anywhere in the paper or in the document properties. Papers with identifying information of any kind will be automatically disqualified. Papers must include an abstract of no more than 75 words. (see Page 19)

#### Minneapolis 2016 Paper Competition (cont'd)

The title should be clearly presented on the first page of text and on running heads throughout the document. ICD accepts papers of up to 25 pages, exclusive of references, tables, and figures. Tables and figures should be placed at the end of the document as reviewers will be instructed to stop reading text after page 25. Font should be 12-point, text should be double-spaced, and margins should be no less than one inch on all sides. Authors should use a style appropriate for the discipline, including APA, Chicago, and Harvard. We will review up to two papers per author, whether the author appears as a single author or as one of several authors.

Please remove identifying information from the document that you submit. Please contact the research chair, Mohammed Al-Azdee <malazdee@bridgeport.edu>, before submitting the paper if you have any questions.

Authors are responsible for following ICD guidelines listed here. Papers that do not meet guidelines will not be reviewed. Submissions will be blind-reviewed. Selections are based on merit.

Awards: ICD awards cash prizes for the top three faculty papers (Stevenson competition) and the top three student papers (Markham competition). First authors of student winners also will receive free conference registration. Both *The Asian Journal of Communication* and *African Journalism Studies* also sponsor a "Best Paper Award" with cash prizes. (Cash prizes are forfeited if an author fails to present the work at the conference.) The Latino/Latin American Research Award sponsored by Florida International University School of Journalism and Mass Communication will honor three top papers in the International Communication or Minorities and Communication divisions with cash prizes and conference registration waivers. All winners of the aforementioned awards will be notified in advance and all awards will be presented at the ICD business meeting during the conference.

# AEJMC-ICD STUDENT INTERNATIONAL MULTIMEDIA News Story Contest-2016

The International Communication Division of the Association for Education in Journalism and Mass Communication, AEJMC, announces its student contest in multimedia news story writing for the year 2015-2016. The contest is open to all undergraduate students.

- Entries must be nonfiction, journalistic stories with multimedia support on a topic related to an international issue.
- **The news story** should have an international angle on a local story or it may be an international story with a local angle.
- It should be a **written story** submitted as a class assignment and/or published on the university website or on a news media Web site (stories published between April 7, 2015 and April 8, 2016 will be considered).
- Stories will be judged based on criteria such as originality, news values, relevance of the story idea, journalistic merit and multimedia support.
- The story as well as the multimedia support should have been authored/executed by the same student.

#### Rules

- (1) Students may enter one news story with multimedia support.
- (2) All elements of the multimedia news story (defined as a **journalistic**, written, online story supported by multimedia elements such as Flash, photography, audio and/or video) should be authored/executed by the same student.
- (3) The completed entry form (one per entry) must be signed by a faculty member attesting to the originality of the multimedia news story and the accuracy of the information provided. The faculty member will have to attest that the story is posted or had earlier been posted on a Web site and provide the correct URL.
- (4) **Submit a printed copy of the story** and mention the correct URL or send a disk with the multimedia elements and send this along with the completed entry form via regular mail.

#### **Awards**

Cash awards of \$100, \$75 and \$50 will be given to the top three entries. In addition, the winners will receive certificates.



potential to provide and validate emerging innovative practices initiated mostly by young leading communicators and journalists, with real world impact across participating global cities. The session is from 3 p.m. to 3:50 p.m.

ICD's pre-conference session will end with a coffee chat with Fred Sam de Lazaro scheduled for 4 p.m. to 4:50 p.m (this is tentative).

For the main conference, ICD is co-sponsoring two research sessions.

The first session co-sponsored with the Minorities and Communication Division is titled: "The Race for the White House: New Research Models and Studies on Latinos and Latin Americans, News Media, and the 2016 U.S. Presidential Election." Members of this panel discuss and debate the inter-play between politicians, news media and Latino voters during the 2016 election campaign. Panelists will discuss a variety of research methodologies, including content analysis of Spanish and English language media and focus groups, that they utilize to study and answer questions about the 2016 presidential election campaigns, such as what is on the political agendas of Latino voters, and what are their priorities? And, do they match up with the dialogue, debate and agendas of those running for president? In addition, the panelists discuss whether news coverage and political agendas are distinct, depending on where or what part of the country news content is published? The second research session co-sponsored with the Cultural and Critical Studies Division is titled: "Wedding Globalization Theory to Critical Cultural Media and Journalism Studies: Issues and Approaches to Research." Globalization theory has influenced the course of research in many other disciplines, including the critical humanities and social sciences, but critical cultural journalism and media studies are relative newcomers to this arena of scholarship. Within the intellectual orbit of AEJMC, these fields have been slow to adopt globalization theory's facility to account for an increasingly interconnected world that is hard to explain using only some earlier theories of international communication or traditional area studies approaches. Leaders of the Association for Education in Journalism and Mass Communication have identified a need for the association to put "globalization" on its institutional agenda, that is, to collaborate with other international organizations and to dispel the idea that AEJMC is a U.S.-centric academic organization. Building on AEJMC's efforts to globalize the organization in a systemic way, this panel attempts to continue the dialogue about globalization by taking up the question of its relationship to research in journalism and critical cultural media studies. The ICD is co-sponsoring two Professional Freedom and Responsibility (PF&R) panels with the Law & Policy Division.

The first PF&R panel scheduled for Friday, August 5, from 1:30 p.m. to 3 p.m., is titled: "Freedom of Information Act 50 Years Later: The U.S. Law Still Serving as the Touchstone?" The year 2016 marks the 50th anniversary of the FOIA in the U.S. and the 250th anniversary of the Swedish Constitution, the first legal guarantee of the right to information. Freedom of information as a legal right was the exception, not the rule, even in the mid-1980s. Today, however, access to information is on the books in more than 100 nations as a constitutional or statutory right. The European Court of Human Rights, the Inter-American Court of Human Rights, and the UN Human Rights Committee have all held that it is a fundamental human right. In celebrating the landmark FOI events in 2016, an important question is what is the actual or perceived impact of the American FOI law abroad and how does it compare with other countries' laws. This panel proceeds from the premise that the tide has turned on government secrecy in recent years but that access to information remains an ongoing challenge for journalism and mass communication educators and practitioners around the world in the post-9/11 era of the global "war on terrorism."

The second one, titled "The Internationalization of Media Law & Policy," is scheduled for Saturday, August 6, from 3:30 p.m. to 5 p.m. This panel will examine how media law and policy are being shaped by global communication patterns and the extent to which media laws and policies are flowing across borders. Since the dawn of the digital era, many scholars and policymakers have predicted that new media technology would globalize communication and lead inevitably to the spread of liberal-democratic values and to a wider international embrace of Western (indeed, American) conceptions of free expression.

The division is also co-sponsoring two teaching panels this year with Electronic News Division.

The first one titled: "Challenges of Teaching & Researching Broadcast or New Media Journalism around the World and in the US." A Fulbright appointment is among the most prestigious awards granted to US and international journalism educators. Yet, the challenges Fulbright Scholars face is little understood. Scholars, who serve abroad, are often posted in countries with limited press freedoms. Appointees also face security and health risks. Teaching in countries where broadcast equipment is outdated and Internet slow is commonplace. International Fulbright Scholars, at US universities, work in English, but it is often their second (see Page 31)

or third language. Many also teach students who are unaware of global interdependence and who lack understanding of the cultural diversity scholars bring. Yet, the work of the Fulbright Scholar can be extraordinarily meaningful. This panel examines the significance of this work and the challenges Fulbright Scholars face. The session is on Thursday, August 4, from 3:15 p.m. to 4:45 p.m.

The second teaching panel is: "Using New Media Technology to Increase Student Engagement in Global Exchanges." This teaching panel will examine the use of smartphones and other widely available technology in the crafting of international learning exchanges. When travel is not an option, this approach represents an emotionally engaging opportunity to interact directly with people in other cultures. Representing advertising, journalism, and public relations, the panelists will discuss examples, best practices, and potential pitfalls and rewards of constructing learning experiences for communications students in a global environment—something that can easily be incorporated into virtually any course on the books. The session is on Saturday, August 6, from 8:15 a.m. to 9:45 a.m.
