

Note from Dr. Jason Martin, 2013 Promising Professor Award Winner



The Mass Communication and Society Division is a leader within AEJMC for rewarding members for their outstanding work in many aspects. In 2013, I had the good fortune to be one such recipient as the firstplace faculty winner of the Promising Professor Award. As a tenure-track faculty member at DePaul University in Chicago, one of the country's largest teaching-focused institutions, I knew this would be a great opportunity to earn outside national-level recognition for my work in innovating and developing our journalism curriculum.

My submission focused on how my advanced reporting elective combined traditional newsgathering skills with public records retrieval, data journalism spreadsheet skills, and data visualization techniques. For their final projects, my students produced multimedia journalism that helped explain the day-to-day struggles of Chicagoans who live in the city's "food deserts" where grocery shopping and restaurants are scarce. These projects also built on the philosophy that I share with many faculty in the

univeristy for using Chicago as our classroom and making a difference in the community. The focus on both reporting from the streets and using data analysis strengthened the result of what citizens could learn about these problems rather than if the approach was limited to only one aspect. It also exposed my students to Chicago's burgeoning open government data community and provided them with skills to help distinguish them when they turn to job seeking.

The Promising Professor session in Washington showcased the breadth and depth of expertise of the other award winners combined with our shared commitment to teaching innovation. For instance, Hyunjin Seo of Kansas described great ideas for incorporating social media into mass communication courses and Anthony Dudo of Texas-Austin offered strategies for handling large-format lectures with greater engagement and interaction. Graduate-student winners demonstrated a range of software and websites to help improve teaching. I left the session with pages of notes and many tips on digital tools and pedagogical techniques.

The final highlight of the session was the outpouring of support and well wishes from colleagues, former students and friends for Jane Brown, who was honored as Distinguished Educator after retiring from the University of North Carolina. Seeing the evidence of the impact she had over her career served as hopeful motivation that I may someday have a fraction of her influence. It was a fitting cap to an afternoon in room full of people committed to continuing to improve how we teach a variety of aspects of the societal role of mass communication.

I encourage anyone eligible to consider applying for this year's Promising Professor Awards, which include the intrinsic rewards I mentioned plus certificates and monetary awards. I also want to thank the division leadership for continuing this great tradition for sharing insights for better teaching that inspire all of us.

Members' Meeting Minutes

AEJMC Convention 8:30 p.m., Friday, August 9, 2013

Opening Remarks: Bu Zhong

(Head) He discussed how we were the largest division at the December 2012 winter meeting. By August 2013, MC&S had 454 members, including 48 international members and 83 graduate students. However, our membership slightly dropped by 18 from 2012. AEJMC's overall membership was 3,741 for 2013, 3,563 for 2012, and 3,494 for 2011. More graduate students join us with a 20% rise (from 66 in 2012).

MC&S Membership Fees:

Our fees (includes Mass Communication and Society) is \$24 for regular member and \$10 for student (reduced from \$14). Other divisions' fees (those with journals): Public Relations (\$30, \$20), Newspaper (\$24, \$8), Law & Policy (\$30, \$7), CTM (\$26, \$16), Int'l Comm (\$25, \$19), Vis Comm (\$40, \$10), Media Ethics (\$26, \$10), Advertising (\$25, \$10), and RTVJ (\$36, \$10).

Division Budget:

Although we remain strong financially, we did see a drop from \$43,682.07 (2012) to \$37,888.46 (2013). Our division's balance was \$43,911.75 for 2011 and \$23,162.85 for 2010. Owing to the fact that New Taylor & Francis contract has increased, we are able to waive some member subscriptions and devote \$1,000 for award/reception. This year's expenses estimated at \$15,000, includes various awards.

Bu Zhong reported a better journal's balance \$344,114.12, compared to its beginning balance \$299,207.49 in 2012 and \$238,801.89 in 2011. Chair proposed new expenditures: set up to \$5,000 for teaching (e.g., community service learning projects); set up to \$5,000 for PF&R (e.g., workshop, symposium, etc.); and set up to \$5,000 for research (e.g., workshop, symposium, etc.). The expenditures were supported through the membership survey in December, 2012 and will be voted to approve this year. Chair proposed the following new expenditures including journal: Add \$2,000 for new associate editor; add \$10,000 for grad/editorial assistant; add up to \$5,000 for teaching; add up to \$5,000 for research; add up to \$5,000 for PF&R, with a total number of \$27,000. Bu Zhong also discussed donation to the 100 year campaign. He reported match up to \$50,000.

Research Report:

Kevin Williams & Jensen Moore (Research Chairs). The division received 145 individual paper submissions. Among them, 76 were accepted, with a 62.8% acceptance rate. In total, 21 were disqualified. All together, 48 papers were rejected by two or more judges. As for paper competition, 108 were submitted with 57 accepted (52.3%). For student competition, 5 submissions were received with 4 of them accepted (80%). More than 100 judges reviewed papers. Without their help and expertise, we would not have a conference. Thank you to all those who reviewed!

Report from Award Chairs:

Gang Han & Seihill Kim (Award Co-Chairs). Open Competition (Faculty papers, student-faculty coauthored papers): Winners receive \$250 for first place, \$150 for second place, and \$75 for third place. 1st place papers are also recognized with a plague. 2nd and 3rd place receive certificates. This year, we recognize 1st place, 2nd place, and 3rd place. 1st place winnder: Robert McKeever, U. of South Carolina. 2nd place winners: Ji won Kim, Monica Chadha, and Homero Gil de Zuniga (University of Texas-Austin) and Valerie Barker, David Dozier, Amy Schmitz Weiss, and Diane Borden (San Diego State University). 3rd place winners are Silvia Knobloch-Westerwick, Laura Willis, and Ashley Kennard (The Ohio State University).

For Student Competition, winners receive \$100 for first place, \$75 for second place, and \$50 for third place.1st place papers are also recognized with a plaque. 2nd and 3rd place receive certificates. This year, we recognize 1st place, 2nd place, and 3rd place. The winners are Ana Keshelashvili, Kenneth Cardell (University of South Carolina), and Lisa Barnard (University of North Carolina).

For Moeller Competition (student papers written in fulfillment of a course), the faculty instructor must write a letter of support. Winners receive \$100 for first place, \$75 for second place, and \$50 for third place.

1st place papers are also recognized with a plaque. 2nd and 3rd place receive certificates. The winners are Edson Tandoc (University of Missouri), Denae D'Arcy, Kyle Heuett, Katie Reno (University of Tennessee), and Wooyeol Shin (U of Minnesota).

Research Award (\$10,000): Any topic that advances mass communication research, especially at the societal or macrosocial level, is eligible for the Research Award. Open to division members only. Winners receive half of the award now and half upon submitting their finished work to Mass Communication and Society within two years. Winners also receive a plaque. This year the award goes to two winners:

"Phase 1 of HIV Prevention among Kenyan Upper Primary School Students via Media Literacy: Kenyan Youth Media Exposure" by William Kinnally & Ann Neville Miller (U of Central Florida).

Teaching Report:

Jay Hmielowski & Melanie Sarge (Teaching Co-Chairs). MC&S had programmed five teaching panels this year (3 in 2012): Promising Professor Award Workshop, How to publish your research papers?, Public Relations and Sports: The Good, the Bad and The Very, Very Ugly, Integrating theory into practical classes, and The Importance of Media Literacy and Strategies for Teaching at the College Level.

Promising Professor recognizes innovation and excellence in teaching. Three faculty awards this year for those who have taught up to 5 years full-time: 1st Place \$250, 2nd Place \$150, 3rd Place \$75. 1st Place receives a plaque, 2nd and 3rd receive certificates. Winners presented at the annual Promising Professors and Distinguished Educator panel. Three winners for the 1st, 2nd, and 3rd places are Jason Martin (De-Paul University), Hyunjin Seo (The University of Kansas), and Anthony Dudo (University of Texas – Austin).

2013 Teaching Awards: Distinguished Educator – our highest honor for teaching excellence and mentorship. This individual received a number of supporting letters from faculty and students in addition to the initial nomination and was featured in this year's Promising Professors and Distinguished Educator panel. The award comes with a \$500 monetary gift this year, in addition to a plaque. 2013 Distinguished Educator goes to Jane D. Brown (University of North Carolina).

Her accomplishments: Has chaired over 30 doctoral committees, 35 master's committees, and 7 undergraduate honors committee; "cares truly deeply about the intellectual and professional development of each and every student in her classes."; instilled confidence in her students and led them through their graduate studies with kind words and meaningful gestures; "A teacher whose smile, generosity, and passion for the discipline inspiring us to 'be like Jane'."; one of the pioneers in understanding the effects of media on adolescent sexuality.

Professional Freedom and Responsibility Report:

Janet Bridges & Jennifer Kowaleski (PF&R Co-Chairs; Done by Bu Zhong). Three sessions and one offsite social focus on PF&R: Wanted: A Free and Responsible Press: The Scholarship of John C. Merrill (1924-2012). The Videogame Industry Matures: The Rise of Older Gamers. Reporting Africa: The Paradigmatic and Diachronic Dynam. Off-site Social: Tour of the Newseum.

Papers related to PF&R: "Idea Plagiarism: A Costly Cultural Norm"; Racial/Gender Inclusiveness: "Cultivating a Dream of Happily Ever After: A Moderated-Mediation Model of Genre-specific Television Viewing, Perceived Relevance, Identification, and Female Adolescents' Beliefs about Romantic Relationships"; Teaching: "Social Networking Sites in the Public Relations Classroom: A Mixed Methods Analysis of Undergraduate Learning Outcomes Using Wordpress, Facebook and Twitter".

Dissertation Award:

Bu Zhong, Division Head & Lisa Paulin, Incoming Head. The Mass Communication and Society Dissertation Award recognizes the top dissertation in the field of mass communication and society, offers an opportunity to publish in the division's journal, and earns a cash prize of \$3,000. The dissertation should address topic(s) that 1) advance mass communication research, especially at the societal or macrosocial level, and 2) emphasize the interaction with society and fit with the division's mission.

Edward Trayes Award:

Bu Zhong, Division Head. Our highest honor for service to the division is presented when an individual has displayed unusual service to the division. The award was established in 1985 to honor Edward Trayes, a leader in the division, AEJMC and the communications field. Today, the award recognizes others who follow Edward Trayes' service example. The award comes with a \$500 monetary gift each year, in addition to a plaque. 2013 Edward Trayes Award goes to Stephen Perry (Illinois State University).

Midwinter Conference Report:

Temple Northup (Midwinter Co-Chairs). 28 papers accepted (40 submitted). Most of the papers were later presented at the AEJMC annual conference. We had a paper session scheduled during every time slot of the conference, the only division to do so. We dominated the Midwinter Conference. A lot of interesting topics. A very friendly conference to go.

Journal Report:

Mass Communication and Society

(Ran Wei, Elected Editor- in-Chief and Stephen Perry, Editor-in-Chief). Four Associate Editors are Francis Lee, Cory Armstrong, Jack Glascock, and Shahira Fahmy. Book Review Editor is John Pollock. We just sent the special issue on London Olympics to press. This year's special issue is on entertainment. Dr. Ran Wei now becomes Editor Elect. 310 original manuscripts (initial submissions) were submitted this year. Screening is now being done by Dr. Ran Wei (desk reviewing and rejections).

265 decisions were made. 39 were accepted. 446 submissions in total during the year (1st submissions, resubmits, etc.)

New editor begins officially in 2014. The first issue in 2014 is filled by the new editor. Bylaws state this person would begin duties one year prior to appointment. Editor's term is 3 years, with the possibility of one additional consecutive term.

By-law Changes:

- 1. Stipend for book reviews editor;
- 2. Stipend for associate editors increases from \$2,000 to \$2,500;
- 3. Add a reviewer award of \$500 for journal reviewers. The editor and associate editors will be the judges;
- 4. Reduced graduate liaison(s) from 2 to 1;
- 5. 2 lottery awards for conference reviewers (conference registration remission);
- 6. Donate the rest of division money (mostly journal budget left) we have back to AEJMC;
- 7. Eligibility of past officers for division awards (only for faculty members not for grad students): 3 years window (after the service year); for promising professors as long as they are not current officers;
- 8. Dissertation Award: If applicants have 1st paper accepted by other journals but as long as a second paper out of the dissertation is submitted to this journal (Mass Comm and Society), they are eligible

PF&R Event in Montreal: A Tour of Pointe-a-Calliere

This year as AEJMC goes to Montreal, your Mass Communication and Society officers have set up a visit to Montreal's Pointe-a-Calliere, Montreal's well known "Museum of Archaeology and History." Montreal is a beautiful and fascinating city, and the Museum provides a unique understanding of its history. We looked at a number of activities available in Montreal and this one seemed to have the most variety and interesting activities.

Where is It? Well known for its variety of collections, the Museum is located within walking distance of our main conference hotel. Museum literature tells us that its site has seen 1,000 years of human development. The site is identified as the "birthplace of Montreal," also known as the "Calliere National Historic Site."

What is It? The Museum has a mandate to "acquire collections related to the history of Montreal"... and takes the responsibility seriously.



It appears to have an exceptional variety of areas developed – from the expected tools and religious objects to items related to games/entertainment and even bodily care/hygiene. Many of the materials used in daily life came from Europe, while some also came from Asia. Some items go back over 4,000 years.

Architectural remains are also a part of the internal facility.

What Will Happen? Our visit will have two parts – covered by our admission cost: first, we will be taken on a guided tour of the museum – plan on at least an hour. Then we will see a thirty-minute multimedia show. After this, if there is more you want to see, for a small fee you are welcome to explore on your own.

Yes, English is spoken clearly.

Timing? Our reservations are for Thursday afternoon (August 7). At this time we are planning to leave the hotel at 1:30 p.m. and walk to the Museum to meet our guide, who will begin our tour.

Children are welcome. This trip will not only make for an interesting and educational afternoon, a focus on cultural inclusiveness fits our emphasis on Professional Freedom and Responsibility. Also:

**Interested in "consulting" the Museum's archaeological and ethnohistorical collections online? Approximately 1,000 data records should be available through digital – see Artefacts Canada or The Info-Muse network of the Societe des musees quebecois.

MC&S Research Award (deadline May 2). Your application with any topic that advances mass communication research, especially at the societal or macro-social level, will be eligible for the award. Your proposal should be submitted electronically in a MS Word file to the Awards Co-Chairs. The total monetary award is up to \$10,000. The winner(s) will be announced at the business meeting in Montreal.

Standard research paper competitions (deadline April 1). The MC&S Division is currently accepting research submissions for the AEJMC annual convention. Please note that your papers should be submitted to only one competitive paper category: Open Competition, Student Competition, or Moeller Student Paper Competition.

To acknowledge research excellence, the Division provides cash awards for faculty \$250 for 1st place, \$150 for 2nd place, and \$75 for 3rd place. For the student competitions the award will be \$100 for 1st, \$75 for 2nd, and \$50 for 3rd, places. The Division will also waive one AEJMC conference registration fee for the top three winners in each research paper competition. The winners will be announced and recognized at our business meeting. Promising Professors Competition and Distinguished Educator Award

The Mass Communication and Society division will continue to host the Promising Professors competition and the Distinguished Educator Award.

The Promising Professors award honors new faculty and graduate students who demonstrate excellence and innovation in teaching. Three junior faculty and three graduate students will be honored at the 2014 conference in Montreal. Winners are required to attend the Promising Professor Workshop and make brief presentations at the Promising Professor Panel.

The Distinguished Educator Award is given annually to a MC&S member whose personal teaching excellence and influence on pedagogy in the field is profound. Typically, a graduate student or former student (current faculty member) nominates the individual. In addition to being honored at the MC&S business meeting at the convention, the Distinguished Educator also will make a formal presentation on teaching during the division's annual Promising Professor's Workshop.


