Outgoing PRD Head **Colleen Connolly-Ahern** presided over the Aug. 11 outgoing board and members' business meetings. Incoming PRD Head **Heidi Hatfield Edwards** presided over the Aug. 12 incoming board meeting. Outgoing Secretary **Susan Grantham** posted minutes for the business meeting, and the incoming secretary **Denise Bortree** posted minutes of the incoming board.

Members' Business Meeting called to order at 8:30 p.m. Aug. 11.

- Last year's minutes approved.
- Elections:

Nominating Committee endorsed Susan Grantham (University of Hartford) for vice head. Nominations closed; elected by acclamation.

Nominating Committee endorsed Natalie Tindall (Georgia State University) for vice headelect. Nominations closed; elected by acclamation.

Nominating Committee and Executive Committee endorsed re-election of Karen Miller Russell (University of Georgia) for a second term as JPRR editor. Approved by acclamation.

- Vice Head Heidi Hatfield Edwards reported that sessions have been well attended. Of 30 panel proposals, six were chipped with co-sponsors Advertising, CommSHER, Internships & Careers, Sports, Mass Comm and Military Ethics. We had one teaching session, one PF&R/teaching session, one research panel, one-high-density session and two poster session. In addition to the Bill Adams/Edelman Luncheon, members had the opportunity to visit the Fleishman-Hillard agency.
- Division Head Colleen Connolly-Ahern announced that the Kaiser Awards will be relaunched to make it a more elite program We are seeking funding for amounts of \$250-300 for each of three annual awards to cover convention registration, AEJMC membership, and assistance with travel and/or meals.
- JPRR Editor Karen Miller Russell said review time is up to an average of 79 days. It was previously 61, but new submissions have been delayed pending revised guidelines compiled by Pat Curtin, Bey-Ling Sha and others that are currently under review. Year-to-date submissions

total 68 with 31 pending. Acceptance rate is up to 30 percent.

- The Roschwalb Award for international student research went to Vanessa Bravo. Karla Gower presented awards funded by the Plank Center to the top student papers. For the first time, we now have Wilcox Award funding for top papers in the open and teaching categories, presented by Dennis Wilcox. Ribbons were also presented to the first, second and third-place visual awards for each of two PRD poster sessions. (See CONVENTION WINNERS on the last page of the newsletter.)

Bey-Ling Sha urged applications from students who have successfully defended for the Grunig & Grunig Thesis & Dissertation Awards competition.

December 1 is the deadline for a special JPRR issue on diversity.

A free Sept. 28 Plank Center webinar will focus on the new agency model.

AEJMC wants divisions to generate 100th anniversary "Big Ideas" to celebrate accomplishments in the association's first century.

The 2014 convention will be in Montreal. PRD members voted a preference for San Francisco, with San Diego a close second, over Palm Desert and Las Vegas.

Adjournment at 9:25 p.m.

The incoming board meeting convened at 7 a.m. Aug. 12. Appointed positions were discussed, and members were directed to the online Operations Manual for an outline of duties. Also discussed were AEJMC training sessions for new officers, the chipping process for convention programming and plans for next year's 100th anniversary convention in Chicago.

# Research Co-Chair **Richard Waters** reports on conference papers.

Even though the 2011 conference in St. Louis just ended, I know several people are already thinking about what they might submit to the 2012 conference in Chicago. I wanted to share a quick summary of the 2011 research competitions. The open paper competition had 67 submissions with 35 acceptances (52.2% acceptance rate) while the student paper competition had 27 submissions with 13 acceptances (48.1% acceptance rate). Additionally, the teaching paper competition had 6 papers accepted from the 10 that were submitted (60% acceptance rate). The overall PRD acceptance rate of 52% was close to the 50% recommended by AEJMC. The number of submissions was down from previous years, and we attribute that to the submission of papers using public relations perspectives to new interest groups, such as political communication and sports communication, and CommSHER's expansion into a division.

As you plan for the 2012 conference, we encourage you to consider submitting to PRD's open, student and teaching paper competitions. The official conference call for papers will be issued later this year with details for the overall conference as well as individual divisions and interest groups. Please read the public relations call for papers as there were 10 disqualifications last year due to manuscripts not adhering to the guidelines set forth in the call. We hope to eliminate those problems for next year's submissions.

Additionally, we will be contacting PRD members and other scholars in the public relations community to sign up to be paper reviewers in January 2012. Last year, we had a fairly successful approach that matched reviewers' topical interests with the papers that were assigned to them for review, and we plan on carrying out that process again this year since it seemed to make the reviews more meaningful for the paper's authors. Together, we can all work toward making the 100th anniversary conference one of the most successful ones yet.
