He taught students "not only what TV news could be, but what it should be."

Washington State University's Glenn Johnson has been named the recipient of the 2008 Edward L. Bliss Award for Distinguished Broadcast Journalism Education. This award recognizes an electronic journalism educator who has made a significant and lasting contribution to the field in the areas of teaching, service and scholarship.

Johnson joins an elite group of educators given the award named for Bliss, a long-time writer and producer for Edward R. Murrow. How appropriate that in this year, as we honor and remember Murrow, our winner comes from the Edward R. Murrow School of Communication.

Professor Johnson has been with the Murrow School in Pullman since 1979, teaching television and radio news writing, producing and management. He is the voice of the WSU Cougar football and men's basketball teams and has served as Mayor of Pullman since 2004.

Johnson's students have gone on to stellar



careers around the northwest and around the country. One former student says "With (Glenn's) help, I was able to understand the true meaning of television journalism. Not only what TV news

could be, but what it should be." Another says of him, "Integrity, passion, dedication, excellence and empathy are all words that describe Glenn Johnson as a professor, a professional and a person."

Johnson was the first educator to be inducted into the National Academy of Television Arts and Sciences-Northwest Chapter's Silver Circle. The Silver Circle comprises media professionals with at least 25 years experience who have made a significant contribution to the television industry and their communities. Former students started an endowment in his name as part of that honor.

Glenn Johnson 101

More than a decade ago, I sat in Glenn Johnson's classroom. For those of us in BDCST 465, Glenn was our professor as well as our first news director. He taught us the lessons we needed to succeed in broadcast news and the lessons in professional freedom and responsibility we needed to attain in journalism. Like Edward R. Murrow, he taught us to strive for truth and excellence in television.

Outside of television, Glenn taught us the value of community. As an active volunteer and, later, mayor of Pullman, Glenn taught us you could do great things in unexpected places. He taught us to believe in ourselves, in our communities and in what our talents could accomplish. He taught us to express our pride: at football games, at basketball games and in all things Cougar.

Today, as a practicing journalist and as an assistant professor, I now have the profound privilege of telling Alaska's stories as well as shaping the next generation of Alaska's storytellers. The lessons from Glenn and the Edward R. Murrow College, however, remain with me. They are lessons in pride, community and excellence I also attempt to pass on to my own students.

As this year's recipient of the 2008 Edward L. Bliss Award for Distinguished Broadcast Journalism Education, Glenn is one most deserving of recognition. His impact and influence extends beyond Pullman to television stations all over the country, even those in the Last Frontier. On behalf of students past, present and future, thank you, Glenn for the important lessons learned.

The Buzz on Strategic Planning RTNDA Considers Partnering with Educators

"Strategic planning" seem to be the buzz words for organizations watching the media industry change at an alarming rate. This year RTNDA cancelled its normal

pre-convention board meeting in favor of a strategic planning session.

Unfortunately our Education Liaison, Denise Dowling, and the other ex-officio representatives were not invited. But the sense of the RTNDA Board at the post-convention board meeting was that the session was quite productive.

I encourage you to read this article and if you have ideas, please let me know; I'm your Education Liaison for next year. There are also email contacts at the end of the article so you can send your ideas directly to the Board.

There were many other more positive signs for a growing relationship between RTNDA and educators from this year's convention. Denise Dowling produced some excellent sessions for the convention, including "Get Hired," "Coaching Young Talent," and "More Than Just a Reporter's Cap: The Many Hats Journalists Wear in the News Production Process." RTNDA also partnered with the Broadcast Education Association (BEA) to produce a super session on "What Would Murrow Do?"

Two sessions from BEA News Division programming were moved to Wednesday afternoon in the Hilton as the RTNDA/NAB/BEA Career Day Sessions. The NAB Education Foundation has always produced those sessions in the past, but this year BEA was allowed to do it.

The sessions included the traditional News Division aircheck session and a session on handling breaking news when it breaks on your own campus. Both were produced by Dana Rosengard and drew large crowds. As a result it appears BEA will produce the Career Day sessions for our students again this year.

The Board reaction to the education programming was very strong and Barbara Cochran and other board members talked about the importance of the relationship with educators and their desire to continue and expand that relationship.

I would also note, for those of you who brought students to RTNDA this year, that we heard quite a bit of complimentary talk about the quality and professional behavior of the students at the convention. One board member noted he thought it was the best group of students he had ever met at a convention. So take pride in your kids!

Clearly the RTNDA leadership has serious concerns about membership and convention attendance, which was down well below a thousand this year. The organization realizes it needs to be relevant to its changing industry and it needs to reach out to members and provide the services they want and need, while still maintaining its vital role as an advocate for electronic journalism with the FCC, politicians and the courts.

That reaching out must include educators. I will continue to push for voting rights for educator members, as well as programming and resources to help you and your students. If you have other issues to be addressed, please let me know.

The good news is the incoming RTNDA Chair next year is Stacey Woelfel, who as many of you know, has one foot in the profession and one in education.

Finally, we need to say a big "Thank You!" to Denise Dowling, who served as your Education Liaison the past two years. Denise produced some great programming for the RTNDA Conventions and brought exposure to educators by getting them on panels. She also created a lot of good will for us, winning high praise from board members.

Something to Think About

Three years ago the RTVJ Division voted to raise membership dues to \$36 in order to fund the new journal, *Electronic News*, and to provide some reimbursement for the travel required of the RTNDA Liaison position. We began collecting the higher dues nearly 18 months before the publication of the first issue of the new journal so there would be a financial cushion until we could see how the costs distributed throughout the year, compared with our collection of membership dues. We also wanted to be sure any start-up or unexpected costs were covered.

We are currently half-way through the second year of the journal publication (Yeah, Charlie and Bob!) and into our third year of providing travel funding for the Liaison position. Currently our balance sheet is relatively unchanged from what it was before the journal began publishing; in fact our cushion continues to grow, though only incrementally now. That is one of the reasons the Division was able to fund our offsite business meeting/social/Bliss award ceremony without asking members to pay a cover charge this year.

While that's a good thing, our division's dues are now the second highest, lower only than those of Vis Com and Community College Journalism, which have \$40 dues. This is one of the items I would like to bring up for New Business at our division meeting Thursday night. Here are some facts to think about in advance of our meeting.

First it's not clear that the higher dues have had a huge impact on division membership, but membership has been somewhat lower in the last three years. Keep in mind that the 2008 numbers only include the first two quarters, which means anyone who renews or joins right around convention time is not included. These are membership numbers for the last seven years:

2008 - 198
2007 - 209
2006 - 218
2005 - 224
2004 - 240
2003 - 263
2002 - 248

The other thing to consider is how our current balance compares with other divisions that have journals. Rich Burke, AEJMC business manager, says that right now, before convention expenses, we're just about where we want to be in terms of a safety cushion, which we need for unexpected expenses or problems. Rich recommends that we maintain our current dues for another year; then we could probably drop back to as low as \$30.

Obviously we should also think about whether we should maintain our current dues level in order to provide other services, such as continuing to fund our offsite meeting at no cost to members, providing more reimbursement for the RTNDA Liaison, and/or creating incentives for research.

So, think about the dues issue, and let's start the discussion this year, in anticipation of a decision next year if you think there's a decision to make.
